Land Conservation: TWC owns more than 200,000 acres of land as preserves, and in aggregate has funded acquisitions of over 750,000 acres on the West Coast. Many statewide and nationally significant conservation projects were inspired by the Conservancy's preserves, which serve as outposts for strategic land-based conservation and stewardship. These include the 154,000 acre Sand to Snow National Monument, named after Wildlands Sand to Snow Wilderness Interface Project, and the 1.6 million acre Mojave Trails National Monument, the second largest national monument in the lower 48 states. The designation of Mojave Trails National Monument was based on the 3 million acres of checkerboard public lands connected by the historic 560,000 acre Conservancy funded Catellus acquisition, which was the largest non-profit land gift to the American people in the nation's history.
